





Get it Published! - How to Navigate the Manuscript Preparation Process

Instructor: Vaughn Paragamian, Codfather Fisheries Consultant

Description: Preparing a manuscript for publication and getting it published is no easy task, even for the most seasoned veteran. When I was an associate editor for the NAJFM I became frustrated for inexperienced writers. Their manuscripts failed because many authors had no training in preparing a manuscript and how to respond to criticism. So I prepared a workshop focused on these problems. This is not a writing workshop, but rather a course on how to avoid the pitfalls of the peer review process.

2016 ICAFS Annual Meeting Special Session Symposium: A Commemoration of the Idaho Supplementation Studies

Supplementation is a hot topic in Idaho and the rest of the Pacific Northwest; this special session on March 9 and 10th, during the annual meeting, will be a timely review of the variety of approaches to the subject.

The Idaho Supplementation Studies was a large-scale, long-term experiment to evaluate the efficacy of hatchery supplementation on augmenting Chinook Salmon populations in Idaho. ISS was implemented by personnel from Idaho Department of Fish and Game, the Nez Perce Tribe, the Shoshone-Bannock Tribes, and the US Fish and Wildlife Service. Field work began in 1991 and the completion report was written in 2015. The project had three phases: baseline, supplementation, and evaluation after supplementation ceased. Such a large project requires the dedication and efforts of many people. In this two-part symposium, we recognize those who participated and the good work they did. In the first part, speakers who took part in the project during the various phases of ISS will document what it took to plan, implement, and successfully complete such a project. The general results and interpretation from the final analysis will also be presented. In the second part, invited speakers will report examples of supplementation projects from across the Pacific Northwest. Invited speakers include: Ed Bowles, Eric Leitzinger, Chris Beasley, David Venditti, Ryan Kinzer, Bill Bosch, Joe Bumgarner, Tim Hoffnagle, Susan Ireland, Eric Stark, Bill Young, and Christine Kozfkay. Lifetime Achievement Award



Lee Mabey, United States Forest Service, Candidate for Vice President

As a member of AFS for the past 20+ years, Lee has received much from the profession. He has followed a similar path as most, working seasonally for many agencies. He spent a few years in fish culture and has been employed with the Forest Service for over 20 years with the last 16 in south east Idaho on the Caribou-Targhee National Forest. His primary professional interests have revolved around fish habitat and passage restoration, with some dabbling in small FERC projects. Working with many great partners in south east Idaho has allowed Lee and his team to accomplish much over the years. He believes that it is truly through partnering that the great work gets done. As resource professionals it seems the demands on water are ever increasing along with negative pressures from introduced species. The bad news seems to out-

Dan Schill, Idaho Department of Fish & Game, Candidate for Vice President

Dan earned a B.S. degree in Biology from Clarion State in 1980, his M.S. in Zoology from Idaho State in 1983, and a Ph.D. in Fisheries Resources from the University of Idaho in 2009. He began his Idaho Fish and Game career in 1982 on the South Fork Snake River, eventually holding a variety of agency positions in both research and management. Since 2004, Dan has supervised the IDFG Fishery Research program. He has been a member of both ICAFS and the Parent Society since 1980 and has served in a variety of AFS capacities including the ICAFS Habitat Committee (1986-88), ICAFS Nominating Chair (1994), Fisheries History Section (1999-2002), WDAFS Bull Trout Committee (1994-1995) and the National AFS Nominating Committee (1999-2000). One of his main forms of AFS involvement has been the technical review process and since the early 1990's has been a referee for nu-



merous NAJFM, TAFS and *Fisheries* papers. He also served two stints as an Associate Editor for the NAJFM totaling roughly 6 years. Dan has presented or co-authored over 15 papers at ICAFS meetings on a wide variety of topics over the years. He is an affiliate faculty member at Idaho State University, Boise State University, and the University of Idaho and takes an active interest in student mentoring. Although often attending and presenting at National or Western AFS meetings, Dan considers Chapter meetings the heart and soul of the American Fisheries Society and is especially fond of the ICAFS meetings for the consistent high quality of the papers presented there. He is extremely honored to be nominated for the position of Vice President and, if elected, promises to work hard at continuing the ICAFS traditions of strong science, ongoing professional development and cross -generational mentoring.

Dan Dauwalter, Trout Unlimited, Candidate for Secretary/Treasurer



Dan earned his B.A. in Biology and Environmental Studies from Gustavus Adolphus College (St. Peter, MN) in 1999, his M.S. in Aquaculture/Fisheries from the University of Arkansas at Pine Bluff in 2002, and his Ph.D. from Oklahoma State University in 2006. From 2006 to 2008 he worked at the University of Wyoming with Forest Service Region 2 to develop long-term monitoring plans for management indicator species. Since 2008, Dan has been a Fisheries Specialist with Trout Unlimited's science program where he has worked on projects ranging from landscape-scale aquatic assessments as strategic planning tools for Trout Unlimited and its partners to small-scale projects understanding habitat selection by stream fishes in a restoration context. Dan has served AFS at all levels. At the national level, Dan has chaired the Continuing Educa-

tion Committee (5 years), served on the Skinner Memorial Award, New Initiatives, and Excellence in Fisheries Education committees of the Education Section, and served as the Newsletter Co-Editor and Western Division Representative for the Education Section. Dan has also served on the Publication Awards Committee of the parent society. At the state level, he has served on several committees of the Colorado/Wyoming and Oklahoma chapters. Dan also served three years as President of the Oklahoma State University student subunit. 
